CATEGORY A: Drugs taken by many pregnant women and women of childbearing age, without any proven increase in the frequency of malformations or other direct or indirect harmful effects on the fetus having been observed.

CATEGORY B1: Drugs taken by only a limited number of pregnant women and women of childbearing age, without an increase in the frequency of malformation or other direct or indirect harmful effects on the human fetus having been observed. Studies in animals have not shown evidence of an increased occurrence in fetal damage.

CATEGORY B2: Drugs taken by only a limited number of pregnant women and women of childbearing age, without an increase in frequency of malformation or other direct or indirect harmful effects on the human fetus having been observed. Studies in animals are inadequate or may be lacking, but available data shows no evidence of an increased occurrence of fetal damage.

C: Compatible with breastfeeding.

CC: Compatible with breastfeeding, use caution

SD: Strongly Discouraged in breastfeeding

CI: Contraindicated in breastfeeding

ND: No Data

CATEGORY B3: Drugs taken by a limited number of pregnant women and women of childbearing age, without increase of malformation or indirect harmful effects on human fetus having been observed. Studies in animals have shown increased occurrence of fetal damage, however the significance is uncertain in humans.

CATEGORY C: Drugs that, owing to their pharmacological effect, have caused, or may be suspected of causing, harmful effects on the human fetus or neonate without causing malformations. May be reversible.

CATEGORY D: Drugs that have caused, are suspected of causing, or are expected to cause increased instances of human fetal malformations or irreversible damage. These drugs also have adverse pharmacological effects.

CATEGORY X: Drugs that have such a high risk of causing permanent damage to the fetus that they should not be used during pregnancy or when there is a possibility of becoming pregnant.
